REQUEST FOR LICENSE
INACTIVATION WITH CAUSE AND
ORDER INACTIVATING LICENSE
WITH CAUSE

8 1. I, PHILLIP J. RUBIN, M.D., am the holder of License No. 7824 to practice
9 allopathic medicine in the State of Arizona.

10 2. I hereby request that, effective at 12:01 p.m. on the date of the following order,
11 the Arizona Medical Board ("Board") inactivate with cause my license to practice
12 allopathic medicine number 7824. A.R.S. §32-1452(F). I participated in the Board's
13 Monitored Aftercare Program from 1984-1986. I have now relapsed.

14 3. I will not practice medicine in the State of Arizona or any other state, territory or
15 district of the United States or a foreign country while my Arizona license is inactive. I
16 may not hold or maintain a controlled substance certificate with the Drug Enforcement
17 Administration or write or refill prescriptions as long as my license is inactive. If I practice
18 medicine while my license is inactive I will be practicing medicine without a license and/or
19 without being exempt from licensure, a felony.

20 4. I shall not request reactivation of my license to practice medicine in the State of
21 Arizona until I comply with all requests of the Board, which may include, but are not
22 limited to, long-term inpatient treatment, psychiatric and psychometric evaluations,
23 physical examination and testing, and written and/or oral competency examinations. The
24 Board will not reactivate my license until I present evidence satisfactory to the Board, in its

1 sole discretion, that I am medically competent and mentally and physically able to safely
2 practice medicine.
