**ORDER FOR SURRENDER OF
LICENSE AND CONSENT TO THE
SAME**

(Non-Disciplinary)

9 Georg Hernandez, M.D. ("Respondent") elects to permanently waive any right to a
10 hearing and appeal with respect to this Order for Surrender of License; admits the
11 jurisdiction of the Arizona Medical Board ("Board"); and consents to the entry of this Order
12 by the Board.

13 **FINDINGS OF FACT**

14 1. The Board is the duly constituted authority for the regulation and control of
15 the practice of allopathic medicine in the State of Arizona.

16 2. Respondent is the holder of License No. 13413 for the practice of allopathic
17 medicine in the State of Arizona.

18 3. On August 18, 2014, Respondent informed the Board he is no longer able to
19 practice medicine due to a physical disability and has retired from the practice of medicine.
20 Respondent requested the Board accept the surrender of his license.

21 4. There has been no finding of unprofessional conduct against Respondent.

22 **CONCLUSIONS OF LAW**

23 1. The Board possesses jurisdiction over the subject matter hereof and over
24 Respondent.

1 5. All admissions made by Respondent are solely for final disposition of this
2 matter and any subsequent related administrative proceedings or civil litigation involving
3 the Board and Respondent. Therefore, said admissions by Respondent are not intended
4 or made for any other use, such as in the context of another state or federal government
5 regulatory agency proceeding, civil or criminal court proceeding, in the State of Arizona or
6 any other state or federal court.

7 6. Upon signing this agreement, and returning this document (or a copy
8 thereof) to the Board's Executive Director, Respondent may not revoke the consent to the
9 entry of the Order. Respondent may not make any modifications to the document. Any
10 modifications to this original document are ineffective and void unless mutually approved
11 by the parties.

12 7. This Order is a public record that will be publicly disseminated as a formal
13 non-disciplinary action of the Board and will be reported to the National Practitioner's Data
14 Bank and will be reported on the Board's web site as a non-disciplinary action.

15 8. If any part of the Order is later declared void or otherwise unenforceable, the
16 remainder of the Order in its entirety shall remain in force and effect.

17 9. If the Board does not adopt this Order, Respondent will not assert as a
18 defense that the Board's consideration of the Order constitutes bias, prejudice,
19 prejudgment or other similar defense.
