**ORDER FOR CONTINUING MEDICAL
EDUCATION**

(NON-DISCIPLINARY)

8 At its public meeting on April 1-2, 2009 the Arizona Medical Board ("Board") voted to
9 require Physician to, within six months, complete 15-20 hours of non-disciplinary Continuing
10 Medical Education in medical recordkeeping pursuant to A.R.S. §32-1451(E)(2).

11 **ORDER**

12 IT IS HEREBY ORDERED that Physician shall, within six months, complete 15-20 hours of
13 Board Staff pre-approved Category I Continuing Medical Education ("CME") in medical
14 recordkeeping, and provide Board Staff with satisfactory proof of attendance. The CME hours
15 shall be in addition to the hours required for biennial renewal of his medical license. Respondent's
16 failure to complete the CME will subject him to future disciplinary action by the Board. A.R.S. § 32-
17 1401(27)(r).

18 **RIGHT TO APPEAL**

19 **NOTICE IS HEREBY GIVEN** that, pursuant to A.R.S. § 41-1092.03, any person aggrieved by this
20 decision may apply to the Board, in writing, within thirty (30) days of receipt and request a public
21 hearing with respect to this order. You may request a hearing by filing a notice of appeal. The
22 notice of appeal must be filed with the Board's Executive Director, and should include your name,
23 address, the action being appealed, and a concise statement of the reasons for the appeal. If you
24 request a public hearing, the hearing will be scheduled within sixty (60) days of receipt of your
25 request. If you request a public hearing, you also have the right to request an informal settlement

1 conference by filing a written request with the Board, pursuant to A.R.S. § 41-1092.06, no later than
2 twenty (20) days before the scheduled hearing. The conference will be held within fifteen (15) days
3 after receipt of your request. Please note that you waive any right to object to the participation of
4 the Board's representative in the final administrative decision of the matter if it is not settled at the
5 conference.
