

REQUEST FOR LICENSE
INACTIVATION WITH CAUSE AND
ORDER INACTIVATING LICENSE
WITH CAUSE

1. I, Michael McKinney, M.D., am the holder of License No. 24574 to practice allopathic medicine in the State of Arizona.
2. I hereby request that, effective at 12 p.m. on the date of the following order, the Arizona Medical Board ("Board") inactivate with cause my license to practice allopathic medicine number 24574. A.R.S. §32-1452(F). I participated in the Board's Monitored Aftercare Program from 1998-2003. I have now relapsed.
3. I will not practice medicine in the State of Arizona or any other state, territory or district of the United States or a foreign country while my Arizona license is inactive. I may not hold or maintain a controlled substance certificate with the Drug Enforcement Administration or write or refill prescriptions as long as my license is inactive. If I practice medicine while my license is inactive I will be practicing medicine without a license and/or without being exempt from licensure, a felony.
4. I shall not request reactivation of my license to practice medicine in the State of Arizona until I comply with all requests of the Board, which may include, but are not limited to, long-term inpatient treatment, psychiatric and psychometric evaluations, physical examination and testing, and written and/or oral competency examinations. The Board will not reactivate my license until I present evidence satisfactory to the Board, in its

1 sole discretion, that I am medically competent and mentally and physically able to safely
2 practice medicine.

8 **FINDINGS OF FACT**

- 9 1. Michael McKinney, M.D. ("licensee") currently holds an active license to
10 practice medicine in this state;
11 2. Licensee was under a Board stipulation or probationary order pursuant to
12 A.R.S. §32-1452 that is no longer in effect;
13 3. Licensee is impaired by alcohol or drug abuse.
14 4. The licensee is not presently under investigation by the Board.
15 5. The Board has not commenced any disciplinary proceeding against the
16 licensee.

17 **CONCLUSION OF LAW**

18 Based on the foregoing admissions and findings of fact, the Executive Director has
19 authority to grant Licensee's Request for License Inactivation With Cause pursuant
20 to A.R.S. § 32-1452(F) and A.A.C. R4-16-503.




