ORDER

Based upon the foregoing Stipulation, IT IS HEREBY ORDERED as follows:

- 1. Dr. MAHL shall not practice medicine in the State of Arizona until he meets with the Board and receives its affirmative approval to do so.
- 2. Dr. MAHL shall successfully complete inpatient treatment at a facility or facilities for sexual compulsivity and chemical dependency. The facility or facilities shall be approved by Board staff prior to Dr. MAHL'S admission.
- 3. Dr. MAHL shall sign a release of records to the Arizona Board of Medical Examiners for all facilities where he receives treatment.
