REQUEST FOR INACTIVE STATUS
WITH CAUSE AND ORDER
GRANTING INACTIVE STATUS WITH
CAUSE.

1. I, WILLIAM MICHAEL COCHRAN, M.D., am the holder of License No. 15469 to practice medicine in the State of Arizona.

2. I hereby request that, effective at 12:01 p.m. on the date of the following order, the Arizona Medical Board (the "Board") place my license to practice allopathic medicine, number 15469 on inactive with cause status. A.R.S. §32-1452(F). I was previously under an Order of Probation for participation in the Board's Monitored Aftercare Program. The Order terminated on April 28, 2000. In relation to an on-going investigation the Board's contracted addiction medicine specialist determined that I had relapsed. I am currently receiving treatment.

3. I agree not to practice medicine in the State of Arizona or any other state, territory or district of the United States or a foreign country while my Arizona license is inactive. I understand that I may not hold or maintain a controlled substance certificate with the Drug Enforcement Administration or write or refill prescriptions as long as my license is inactive. I understand that if I practice medicine while my license is inactive I will be practicing medicine without a license and/or without being exempt from licensure, a felony.

I agree that I shall not request reactivation of my license to practice medicine in the State of Arizona until I comply with all requests of the Board, which may include, but are not limited to, long-term inpatient treatment, psychiatric and psychometric evaluations, physical examination and testing, and written and/or oral competency examinations. I understand that the Board will not reactivate my license until I present evidence satisfactory to the Board, in its sole discretion, that I am medically competent and mentally and physically able to safely practice medicine.
