

1 Respondent was to meet with Patient monthly and conduct laboratory studies, including
2 blood work and urinalysis.

3 5. On October 30, 1996, Patient's initial blood work and urinalysis indicated
4 normal glucose levels. Throughout the study Patient did not indicate any adverse
5 symptoms or medical problems.

6 6. On April 24, 1997, blood work indicated a glucose level of 233.
7 Respondent testified that he discussed this glucose level with Patient. However, there is
8 no indication in Patient's chart of such a discussion.

9 7. On November 5, 1997, blood work indicated a glucose level of 456 and
10 urinalysis indicated an elevated glucose. Respondent received the results on November
11 6, 1997 and repeatedly tried to reach Patient by telephone. Respondent was
12 unsuccessful.

13 8. Although the Board's initial investigation indicated that Respondent simply
14 left a message for Patient, Respondent's counsel informed the Board that a deposition of
15 Patient's father revealed that Respondent's staff had contacted Patient's father, with
16 whom Patient resided. Patient's father testified in his deposition that he received the call
17 from Respondent's staff and informed Respondent's staff that Patient was sleeping and
18 could not be disturbed at the time of the call.


19 **CONCLUSIONS OF LAW**

20 1. The Board of Medical Examiners of the State of Arizona possesses
21 jurisdiction over the subject matter hereof and over Respondent.

22 2. The Board has received substantial evidence supporting the Findings of
23 Fact described above and said findings constitute unprofessional conduct or other
24 grounds for the Board to take disciplinary action.


